It was moved by Trustee Farber, seconded by Trustee Abrassart that the treasurer's report be approved. After a roll call vote, where all present voted favorably, the motion was carried.

President O'Connell opened discussion regarding Trustee Ronald Grubbs being made a consultant for the Village at a fee of \$100 per month, plus insurance payment of \$43.94. President O'Connell then stated that he would like the Parks Committee to meet and look at options to build a new concession stand.

President O'Connell stated that he had been in discussion with County Rep, Todd Sirois, to be sure that the resurfacing of Guertin St. would follow all the work with the Water project.

Attorney Parish said he feels the Klonowski project would be wrapped up shortly.

Attorney Parish reported that he was still working on the Weisbecker sale.

Trustee Farber gave the monthly Police report. He read the report as follows: 39 traffic stops, 2 accidents, 7 agency assists ambulance/fire/other agencies, 4 suspicious activity calls persons/vehicles, 462 business checks park checks/no issues, 39 citations were issued/0 local/23 written warnings/ 16 traffic citations, 1 warrant arrest, 1 disorderly conduct/disturbance/fireworks, 6 battery/agg assault/domestic battery, 0 admin tow, 0 criminal damage to property, 1 theft/identity theft. Fines collected were \$336.50, no warrant fees, \$6.00 e-citations, making the total disbursement \$342.50. There were \$0 in golf cart fees, and \$600 collected from Papineau for a total of \$942.50.

Trustee Abrassart said there was nothing to report from the Public Works Dept.

Trustee Stam read the Building Permit report stating 2 permits were issued. The cost of projects was \$45,000 and fees collected were \$292.

President O'Connell stated there was nothing from the Parks Committee, but wanted to be clear on the fact that the DNR would take care of the stocking of the ponds and the Village PW Dept could now handle the weeds.

Trustee Abrassart had nothing to report from Equp. Comm.
