President O'Connell wrote up a Resolution for the issue of the RR crossing on 6000S rd. He stated that the village supports the road stay open for the use of our residents and farmers. Although we do not have the final say in this matter, we are hoping our input along with the Township Board that this will have some impact on their decision

Fines collected were \$436.57 and e-citations were \$0.00. There was \$ 0.00 in administrative tow fines, \$245.00 in golf cart fees, \$0.00 in ordinance fines and \$900.00 collected from Papineau for a total of \$1581.57.

Transmissions on the squads have not been fixed yet. Some additives have been put in until they go in for the repairs. Officer Hoekstra's squad has been brought into Court Street Ford to repair the air bag spring.

The resident at 309 W Beaver questioned the possibility of his sidewalk being replaced at his residence. President O'Connell stated that the Building Inspector will go look and see if it needs to be replaced and will proceed from there.

Public Workers Director Don Leveque stated that there is a good-sized hole on 7000s rd. which is now our road due to an annexation. There is also a culvert north of this road that is need of repairs. Don has a meeting set up with Hobart Weiglus to have him look at it and give us a price for the repairs.

Trustee Abrassart read the building report as written. There was a total of 1 building permit issued with a total value of \$168,000 in value and total fees of \$1310.00.
